APPLICATION SUBMISSION DEADLINE: FEBRUARY 28, 2012

Applications received in the festival office *after the submission deadline of February 28, 2012* will be placed on a reserve list in order of the date received.

ONLY ORIGINAL WORK UNIQUE TO AND CREATED BY THE APPLICANT WILL BE CONSIDERED.

Exhibitors will be selected based on the quality and originality of their work. Should the jury have any questions or concerns, applicants will be requested to submit a sample of their craft.

1. New applicants **must** submit at least four (4) photographs of their work. Photos must be dated and accompanied by a corresponding price list. Returning vendors must submit photos of any new products added to their line. Photographs will be returned **only** if a self-addressed envelope of sufficient size and correct postage is enclosed with the application.
2. New applicants must include a short personal resume.
3. All booths are supplied with one (1) electrical outlet with approx 450 watts of power at 120 volts. We do not have the capacity to add additional power to booths. **FREEZERS & LARGE REFRIGERATORS ARE NOT ALLOWED IN THE BOOTHS. (TABLE-TOP REFRIGERATORS ARE ALLOWED.)**
4. Every effort will be made to comply with specific booth requests.
5. All exhibit spaces are under marquee tents. No individual exhibits outside the tent areas are allowed. Booth walls are plywood. Exhibitors are encouraged to decorate their booths. Hooks and nails may be used to hang wall coverings and display shelving however plywood booth walls may not be altered, cut, or painted.
6. **All applicants must complete and return the entry form below and enclose the full entry fee.**
7. Applicants will be notified by mail of their booth allocation. **No telephone inquiries please.**
